# **Part I: Narrative Summary**

### From the Executive Director

**The** *System Dynamics Society* is an international, nonprofit organization devoted to encouraging the development and use of system dynamics and systems thinking around the world. With members in seventy–two countries, the Society provides a forum in which researchers, educators, consultants, and practitioners in the corporate and public sectors interact to introduce newcomers to the field, keep abreast of current developments, and build on each other's work.

2011 was a very productive year. At the home office, we worked diligently to provide service to all of our members, plan and administer the conference in Washington, D. C., provide prompt delivery of our products, and maintain and improve our web presence.

I would like to thank staff members Erin Sheehan and Robin Langer, who along with additional support from a graduate student at the University at Albany, volunteers, and outside contractors Joan Yanni and LouAnne Lundgren, keep things running smoothly. I would also like to extend a special thank you to Navid Ghaffarzadegan, our graduate assistant for five years, who received his PhD in December.

The home operations fall into five categories: Conference, Core, Publications, Sales, and Web Presence.


# Conference

Conference management is a major part of home office operations for the first seven months of the year. At any one time, work is being done on the past year's conference, the current conference, and planning for future conferences. Time spent on conference management is always a substantial percentage of full year time allocation. Outsourcing is necessary and is a successful way to keep abreast of all the duties. Efforts to improve conference operations are ongoing as always.

By vote of the Policy Council, the Society has moved to a conference location policy which has two default locations, one in North America and one in Europe. The North American default site is Boston and the European site is still being considered. Locations outside these will be considered, on a case by case basis.

The web-based submission system continues to be improved by Bob Eberlein and incorporated into conference management.

Future planning is actively ongoing for the Cambridge, Massachusetts (2013) Conference to be held from July 21 to July 25, 2013. See the preliminary *Call for Papers* with your conference materials.



# Core

Membership constitutes the primary core activity of the Society. In 2011, our membership totaled 1,125. All memberships are processed through this office. The home office goal is to provide accurate, prompt and personal service to all members and prospective members.

We include a membership option on the conference registration. For the Washington, D.C. (WDC) conference, we processed 69 memberships, of which 45 were **new** members. Please see Attachment I – Conference, A-**Conference Attendance Statistics**, *Conference Registration Fee Structure*, 2002-2011 (table 3), page 8.

After the annual conference, a personal invitation for membership is sent to non-member conference attendees. In addition, our renewal campaign includes monthly email messages or letters to members who did not renew.

We began offering memberships with electronic-only delivery of the *System Dynamics Review* in 2006. That year only 4% of members chose electronic-only but this has increased steadily to 36% in 2011.

The Society receives and processes membership for a particular year from September of the previous year to March of the following year (19 months). In 2011, 74% of our 2010 members renewed, which is a similar rate to the last few years. (The average over the last 13 years is 78%.)

Other Core services include support to Chapters and Special Interest Groups. In 2011, the Chapter Development Fund was established and the home office processed the first fund request.

# **Publications**

Publication of the System Dynamics Society newsletters, the Bibliography, and support to the editors in the publication of, as well as, support to the members in the access of the *System Dynamics Review* are other home office duties.

The *System Dynamics Review* is published by Wiley-Blackwell four times a year. In January of 2011 a new contract commenced. As part of that contract a reduced e-subscription rate for members was introduced. Also in 2011, work began on a new access arrangement that was launched in January 2012.

We continue to build on the existing, successful partnership we have with Wiley-Blackwell. The current contract runs from 2011 until 2018.

There are usually four newsletters produced each year by home office staff. The March, September, and October newsletters feature a message from the president of the Society and other Society news. In June there is a Special Issue on Sponsor News. Conference reports are the mainstay of the October newsletter. Three newsletters were produced by office staff in 2011.

The System Dynamics **Bibliography** is maintained by an in-office bibliographer with scheduled published updates. The System Dynamics Society Bibliography is downloadable from our website. The bibliography has been updated to include the *Proceedings of the 29<sup>th</sup> International Conference of the System Dynamics Society* and the *System Dynamics Review* Volume 27, Number 1-4. New entries and corrections are continuously being made, as the bibliography is always a work in progress; currently there are 9,873 entries.


Number of Bibliography Records, by year, 2002 – 2011

# Sales

The Beer Distribution Game, Conference Proceedings, Journal, Bibliography, PhD Seminar Series and MIT Literature Collection can all be purchased from the Society.

Interest in the Production Distribution Game (Beer Game) increased slightly in 2011; the Society sold 570 boards in 2011 after a record setting 1,086 in 2008.

We continue to sell hard copies of back issues of the *System Dynamics Review*, but this is not a large income source. Access to past journals through our publisher using the Wiley Online Library website has influenced the sales of the past issues of the Review. In accordance with the 2011 contract with Wiley, past issues of the Review are available for sale to members of the Society. The last of the complete sets of back issues were sold during the special sale in 2010.

In 2011, the \$51,624 net income from the sales "cost center" helped support all operations offered by the Society office.

# Web Presence

As part of the project to use a content management system (CMS) for our website, we met with a web design/development firm to learn about some alternatives. The design firm proposal also included training so staff could perform routine tasks and develop new pages for the web site. The 2012 conference page, along with all links and companion pages, was launched in 2011. Additional new pages using content management include one for the Case Repository. The redesign is an ongoing effort at the home office and we are working to make new features available as soon as possible.



The Society office website has been hosted by CirtexHosting since December 2010. To keep abreast of technological advancements, development funding must continue to be placed in the budget for web presence. Our website includes an online discussion forum and, in February, a Facebook page was created.

# **Cross Category Issues**

# Sponsorship

Of the 36 Society sponsors that sent a gift or traded services, there were six new sponsors in 2011. Our sponsors are very committed, 23 of our 2011 Society sponsors have been sponsors for three consecutive years or more.

The Society office performs a systematic Society sponsorship program contacting all past Society sponsors and conference sponsors, inviting them to continue their support. In addition, we identify and mail letters to repeat customers, to organizations with numerous members and to other consulting firms owned by members. This mailing is not only to solicit, but also to cultivate a relationship, to involve our members and others in the field of system dynamics. E-mails sent for the 2012 Society Sponsorship Campaign totaled 815.

A sponsor receives up to three personal memberships with a sponsorship and can purchase additional memberships at a discount. A total of 99 new or renewed members joined the Society for the calendar year 2011 as a result of the Society Sponsorship incentive.



### Finances

As stated earlier above, the Society is managed around five cost centers: conference, core operations, publications, sales and web presence. Please refer to the VP Finance report for full details. All bookkeeping files are maintained in QuickBooks. In 2011, the Society interviewed, hired, and transferred to a new CPA, Tom Hosey of Lubbe & Hosey, PC.

The investment plan for the Dana Meadows Endowment Fund, student prize restricted accounts, of \$60,000 is being maintained.

An overall investment policy for the Society was implemented in 2005 and continues to be maintained. As per our investment consultant suggestion, rebalancing is done annually to achieve the original weighting in the overall investment policy.

#### Conference Tasks: Responsibilities for conference activities have included, but are not limited to:

- Design/produce/mail the Call for Papers brochures, conference information and registration brochures, including electronic formats
- Advertise in related journals
- Contact conference sponsors including generating new contacts
- Maintain office and site finances in QuickBooks and Excel
- Manage registrations
- Organize and schedule meetings and events, including assignment of chairs
- Use of web submission system to manage all aspects of submissions and review
- Produce the printed abstract proceedings and web proceedings
- Support award committees, manage as needed: submissions, ceremonies, scheduling and handouts to recipients for Dana Meadows Student Prize Award, Jay W. Forrester Awards, Applications Award, Outstanding Service Award, Lifetime Achievement Award; and assist with outside awards.

- Event Insurance Coverage
- Design layout of conference sponsor information
- Organize outsourcing for specialty work
- Use of web submission system to manage the tentative and final program
- Schedule session chairs, room assignments and AV equipment arrangements
- Organize the Poster Symposium
- Assist with all social program items including transportation
- Maintain the conference website
- Negotiate and work directly with the conference venue
- Work with Program Chair as needed
- Assist in implementing any new program features
- Organize all pre-conference and during-conference outside contractor and volunteer labor
- Assist participants with: any attendance issues, including funding transfer issues and letters of invitation for visas; roommate contacts; finding appropriate lodging; and manage other unique site-specific challenges.


Membership Distribution by Sector, 2005 – 2011
