Your assessment of the closing year

We really can only report on our own activities. We have not been successful in engaging Psychology SIG members.

Dr. Lounsbury is teaching system dynamics at the Albert Einstein College of Medicine and the Ferkauf School of Psychology at Yeshiva University, Bronx, NY. He is mentoring multiple medical students and clinical psychology graduate students. Dr. Lounsbury has approximately 10 on-going modeling projects that are focusing on diverse medical and public health issues, including HPV vaccination, tobacco treatment, HIV care quality, psychological dynamics of women at risk of HIV, social media-based HIV prevention messaging, cancer clinical trials support, and adolescent obesity. Interest in and demand for system dynamics modeling expertise continues to grow rapidly at Einstein and at other universities in the New York City region.

Dr. Levine, professor emeritus at Michigan State University, continues to work on two research grants this year that focus primarily on developing system dynamics models of public health problems with particular stress on behavioral and psychological processes. The first grant deals with modeling the effects of climate change on community health. More specifically, it deals the modeling effects of extreme heat episodes on vulnerable populations, such as elder citizens who have pulmonary and cardiac illnesses. This model will include a large number of psychological and behavioral mechanisms. A second grant (NIH) deals with the public health issues of dental caries by modeling the dynamics of habit change. More specifically, the model will deal with getting parents and their children to brush their teeth more often. The principal researcher on this project is Dr. Deborah Polk, University of Pittsburgh, College of Dentistry who is member of the society.
