2. Conference Proceedings

Background. In 2013, Kim Warren as President of the Society appointed an ad hoc committee consisting of Bob Eberlein (VP for Electronic Presence), Len Malczynski (VP Meetings), and George Richardson (VP Publications) to consider changes to the way our conference proceedings are handled.

We began with the thought that to grow the reputation of the field our conference proceedings ought to focus on high quality work. That suggested publishing only abstracts of all papers and presentations together with full papers of a selection of the best work at the conference. That thought went through five drafts as we consulted with the Publications Committee (Susan Howick, Etiënne Rouwette, Ed Anderson, and Sara Metcalf), recent and current conference program cochairs (Pål Davidsen, Etiënne Rouwette, Khalid Saeed, Karim Chichakly), and others including John Sterman, David Andersen and Roberta Spencer.

Resolution. In the end, Len Bob, and I concluded that the proper course of action is to continue with conference proceedings as we have had them in the past, reproducing all abstracts and papers presented at the conference, but contained not in a printed document or on CD but rather maintained on the Society web site as **Web Proceedings**.

In an effort to capture the richness of the thinking that our process involved, we have decided that the following paragraphs characterize essential understandings about our conference proceedings and should appear in the Call for Papers and all announcements about drafts and final copy for the Web Proceedings:

Conference papers and presentations are a networking tool for members of the Society and those who attend a conference. The Conference provides a venue for presenting work and receiving comments that can strengthen the work and help to prepare it for wider distribution.

The Society will produce and maintain Web Proceedings of abstracts and papers to provide a complete record of presentations at the Conference. The Web Proceedings are not intended to be a substitute for publishing in peer-reviewed journals.

The strength of the field requires publishing good work, reaching audiences beyond those attending our conferences. Consult with experienced professional system dynamics colleagues for suggestions on making your work ready for publication and for suggestions of where to publish.

Abbreviating your paper for the Web proceedings is a good idea if you intend to publish it after the conference, as many journals will refuse to publish the same paper that has appeared elsewhere, including conference proceedings.

3. Main aims for 2015 by Pål I. Davidsen

For 2015, we have five important issues to address;

• We propose a Publication Strategy be developed for the System Dynamics Society. We have a variety of audiences we potentially would like to reach, we have a number of communication channels to choose between, and we have a variety of "messages" to convey to our audience. So it would be important to consider seriously how the SDS should prioritize and spend its resources most effectively in that regard. Such a policy will be closely related to the work that Bob Eberlein and Peter Hofman are doing as VP's of Electronic Presence and Marketing and Communication, respectively. Consequently, the Publication Committee has appointed David N. Ford to lead the work developing of a

Publication Strategy for the System Dynamics Society. David will form a reference panel (ad-hoc committee) consisting of Bob, Peter and other members of our society that may assist us in developing such a strategy. He will report on a regular basis to the Publication Committee and share the issues he addresses with that committee so that we may have an opportunity to respond and offer our input. We expect a preliminary report to be presented to the Policy Council of the SDS in our Boston meeting this summer and for a Publication Strategy to be adopted by the Policy Council in February 2016.

- The current Editor of the System Dynamics review, Rogelio Oliva, has announced that he will resign from this position as of December 31., 2015. Needless to say, we would like to see him continue his excellent work. Unfortunately he is determined to step down. It is our responsibility to nominate a candidate for this important and demanding position. It will not be an easy task to find suitable candidates that are willing to step up. We will start that work now and will ask for suggestions from the membership.
- In May we will participate, together with Roberta, in the SDS annual meeting with our SDR publisher Wiley. In the meetings, issues raised by the Publication Committee, the Policy Council, Officers of the Society and the Home Office will be addressed.
