Nominations Process

Nominated officers were identified following a structured process. First, committee members met to review the requirements of each open position as well as to review the criteria suggested in previous Nominating Committee reports (i.e., Society membership, conference participation, contribution to the field, among others). These criteria included impacts on diversity of age, gender, and cultural/geographic origin among the Society's leadership, as well as the person's interest in serving. Some nominations had already been received from repeated open calls for nominations to all Society members, and committee members reviewed and discussed the available nominations.

Second, committee members initiated a complementary process of searching for and nominating

additional candidates. In addition, committee members reached out to the Society's Home Office to request active support by pro-actively making the committee aware of potential candidates from more diverse backgrounds.

Third, as the proposed nominees for different positions consolidated, a set of thorough discussions involving all committee members ensued, resulting in a ranking of nominees for each position. Diversity (e.g., age, gender, geographic origin) was a main concern of the committee, but candidates were chosen based on their individual merits, accomplishments, interest, and perceived possible contribution to the society in the specific role.

Fourth, potential candidates for each position were approached individually, starting with the highest-ranking candidate. An individual conversation followed with potential questions and concerns of nominees being addressed. All nominees have agreed to take office should their nomination be approved by the Policy Council.

Additional Notes and Recommendations

- VP Publications significant effort was taken into consideration to have a VP with broad editorial experience and prior experience negotiating with Wiley and/or other publishers.
- VP Finance we recommend that the current VP work hard to identify one or more Associate VP(s) that could potentially take over this role in the future.
