


VP Meetings Update: Net Conference Revenue

VP Meetings Update: Submissions and Attendance



- We've maintained a strong base of non-submitting attendees which we generated in 2020

- To meet budget in 2024 and 2025 we must recover submissions!

VP Meetings: Recommendations

- **1.** *Grow Sponsorship*: Build an organizational structure capable of generating continued and reliable sponsorship
- 2. Grow Submissions: Focus on conference submission email marketing
 - Clear email subject lines and body content aligned
 - Restart marketing of innovative submissions types (WIP, Applications)
 - Market innovative presentation types (i.e., Table Talks)
 - Draft emails in Q3/Q4 2023 (allowing time for Office to be creative)
 - Avoid competition in last 4+ weeks of submission period
 - Avoid promotion of invited Plenary speakers during submission period
- Open registrations at the same time as submissions (January 16, 2024)
- Plan ahead! Submission deadline is March 19, 2024

Election Process (Lees)

Next steps:

- Ask nominees if they'd like to engage as candidates.
- Discuss how we envision the voting/campaign process playing out since we have not encountered this recently (PC discussion).
- Set up a voting process that assures anonymity and one member-one vote restriction.
- Gather pictures, bios and vision statements (300 words total) from candidates to be disseminated.
- Send an email to all members with access to both the candidates' information and the voting process, reminders 2 weeks and 1 day before the deadline.
- Tabulate the results 30 days after the original email is sent (estimate by the end of October).

How do others do this? An example that seemed to make sense:

The Academy of Management values elections that are free of active "politicking." It is certainly appropriate to ask fellow members of the Academy for further information about a candidate you do not know. However, recommending candidates to others or actively campaigning is inappropriate and inconsistent with the way we operate as an association. "Campaigning" within the Academy community is defined as attempting to influence the vote of others or promoting one candidate over another.

Motion to approve the following procedure in Society campaigning:

System Dynamics Society resources shall not be used for campaigning.

The Society suggests that members engage in positive comments about candidates and do not engage in negative comments about candidates.

The Society will send out a neutral statement about the status of the nomination process with bios and platform provided by the candidates. This will include the candidate's email addresses.

A) Candidates shall not engage in campaigning, e.g. proactively reaching out to members in advocacy of their candidacy or opposition to another; other than responding to direct inquiries by members.

B) Candidates shall not engage in any campaign activities beyond personal outreach and answering questions.

Motion to approve the following procedure in Society campaigning: Use of System Dynamics Society resources for campaigning is inappropriate.

The Society suggests that members engage in positive comments about candidates and do not engage in negative comments about candidates.
