- Refresher on voting process

Voting Process: Robert's Rules of Order

- **Motion is Made** – A member proposes an action.
- **Motion is Seconded** – Another member supports discussion.
- **Discussion** – Members debate the motion.
- **Amendments (if any)** – A member proposes a change. If seconded, the amendment is discussed and voted on *before* returning to the main motion (which may now be modified).
- **Repeat Amendments if Needed** – Multiple amendments can be considered sequentially, but only one can be debated at a time.
- **Call for Vote** – Chairperson calls the question on the final motion (amended or original).
- **Voting Occurs** – Methods may include voice, show of hands, roll call, or ballot.
- **Result Announced** – Chair states the outcome and next steps.
- **Electronic Voting** - people can request and vote on an electronic vote

SDS Voting Rules - Votes Required

- **Votes needed to change:**
 - [Articles of Organization](#): $\frac{2}{3}$ of members “qualified to vote and voting”
 - [Bylaws](#): $\frac{1}{4}$ of members “qualified to vote and voting” responding with $\frac{2}{3}$ vote
 - [Policies](#): $\frac{3}{5}$ of voting members of PC
- **Minimum vote for:**
 - **Vacancies in Policy Council**: $\frac{1}{2}$ of voting members of PC present at Meeting
 - **Committees to take binding action**: $\frac{2}{3}$ vote of all committee members
 - **Add Chapters or SIG**: $\frac{1}{2}$ of voting members of PC
 - **# of people on PC**: $\frac{1}{2}$ of voting members of PC
 - **Remove person from PC**: $\frac{2}{3}$ of voting PC members or $\frac{1}{2}$ of members
 - **Remove officer, employee, or agent**: $\frac{1}{2}$ of voting members of PC
 - **Remove Finance/Audit/Stewardship Committee member**: $\frac{2}{3}$ vote of members

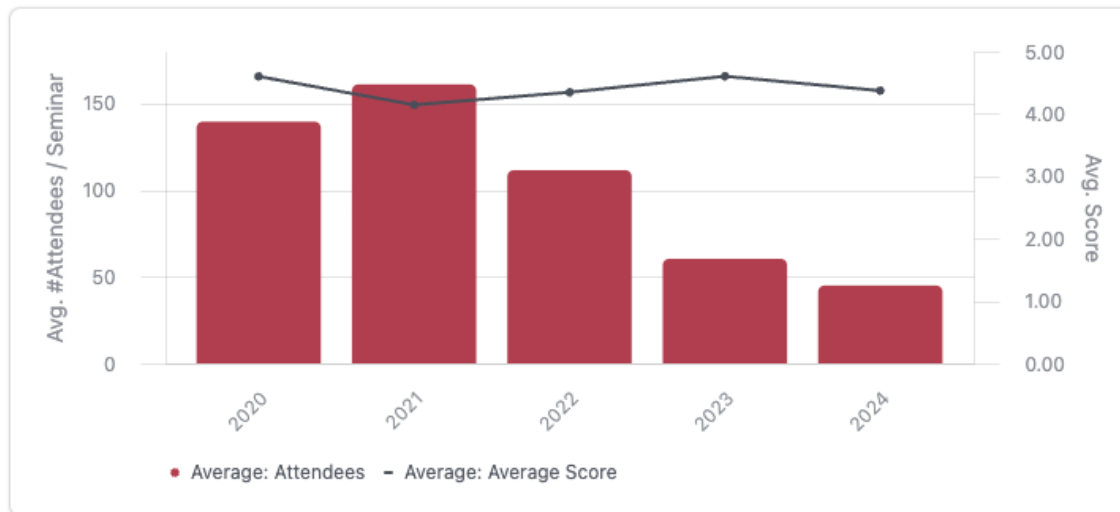
