System Dynamics Society General Business Meeting July, 2012, St. Gallen, Switzerland

David Ford called the meeting to order at 8:35.

A motion to approve the minutes of the 2011 General Business Meeting was made by David Lane, seconded by Rogelio Oliva, and passed.

Officer Reports:

a) VP of Finance – David Andersen

David summarized our history, beginning in1996 when we went to professional management of the Society. Now today, we have net assets a little over \$800 K. Society finances are in good shape overall. We operates as a 501c3 corporation, registered in NY and MA. Based on our budget for 2013, we expect to spend \$536 K, and we expect a net gain of \$382. The main sources of revenue are three volatile sources: sales, conference fees, and earnings from investments.

- b) VP of Electronic Presence Bob Eberlein Bob reported that the new website is up. He is would like volunteers to help, for example, as contributors of content to web site. He is also working on the submission system that will be renamed as the System Dynamics portal.
- c) VP of Chapter Activities Martin Schaffernicht

Martin referred us to a complete report available on the Society website describing several chapter development initiatives. Chapters are an important part of the Society, and Martin encouraged individuals to get in touch with a chapter or SIG to affiliate with one or more of them. He invited chapters to contact Martin for help as needed.

d) VP of Meetings - Andreas Groessler

Andreas extended an invitation to all to attend next year's conference in Boston in 2013. The 2014 conference will be in Delft at TU Delft.. Delft will be the default European conference site. Proposals from other sites are welcome; the default site concept means that in the absence of a superior proposal from another site, the European conference will be at Delft. We need some "routine" in running the conference repeatedly as the same site in Europe.

e) VP of Member Activities – Etienne Rouwette

The VP of Member Activities also deals with the SIGs. SIGs hold meetings and have round tables at the conference, and there are still opportunities at this conference to attend. We have a new SIG: Biophysical Systems. All SIGs are run by volunteers. As VP, Etienne is trying to understand needs of the SIGs and how the Society can help. Also, we are trying to create repository of successful SD cases.

f) VP of Publications – George Richardson

The VP of Publications has two roles. One is to chair the Publications Committee. The other is in rare times to nominate the Executive Editor of the System Dynamics Review. Rogelio Oliva is our new Executive Editor. George expressed the appreciation of the Society to Brian Dangerfield for his exemplary service as Executive Editor for more than 10 years. The Publications Committee is now on a stable rotation, including members Etienne Rouwette, Ed Anderson, and Susan Howick. George encouraged us to read Rogelio Oliva's report to the PC. Thanks also to Graham Russell and Wiley/Blackwell for excellent things they do for us, particularly in the realm of electronic presence.

- g) Executive Director Roberta Spencer Roberta reported that the Society is running like a Swiss watch. The home office report is available here for those who want a copy and can also be found on line. Roberta introduced the professional staff and extended an invitation to all to visit in Albany.
- h) Nominating Committee David Lane David issued a call for suggestions for nominations. There are places open on the PC for three year terms. Please send nominations to David Lane.
