



4. Proposed By-law Changes

The Policy Council of the System Dynamics Society has recommended an update to three sections of Bylaw V. Officers to reflect a change in status of Founding President, Jay Forrester. Jay continues to work closely with the Policy Council but, over the past several years, he has been moving to a more advisory position.

Proposed NEW Wording- BYLAW V. OFFICERS: a. President. The President shall preside at all meetings of the Policy Council and of the Society, performing all duties required by the Bylaws and Policies as well as any additional duties specified by the Policy Council.

Proposed NEW Wording- BYLAW V. OFFICERS: Founding President: The Founding President shall serve as a non-voting advisor to the Policy Council.

Proposed NEW Wording- Section 1. Title and Authority. The officers of the Society shall be a President; a President Elect; a Past President, one or more Vice Presidents, as specified by the Policy Council; and a Secretary.

The proposed by-law changes were described and the floor was open for discussion. Following the General Business Meeting, a ballot will be held of the entire membership by electronic vote to approve or disapprove the changes.
